I am pleased to invite you to the 3rd Workshop on Risk Management in the context of rail, road and waterways Transport of Dangerous Goods. This workshop will take place from 17th to 19th February 2015. It will start at 13:30 on the first day and will end not later than 13:30 on the last day.

The following topics will be discussed:

- Existing content of databases on transport events
- Existing processes for collection of transport events data

- Potential contribution of telematic applications to data collection processes

For facilitating the discussions, the Agency will prepare, on the basis of received inputs from the participants, two draft summary documents: a) on the types of information collected today and; b) on existing data collection processes.
