Gala Dinner – 3 October 2012

Hosted by Marseille Fos Port Authority, the Gala Dinner will be held in the main hall of the Chamber of Commerce of Marseille. The oldest in France, it was founded in 1599 and four deputies were appointed to defend the interests of commerce, and consequently that of the port. The Marseille Chamber of Commerce and Industry still plays a vital part in the city's business transactions.



Port Tour – 5 October 2012

Starting from the Vieux Port, the tour will allow delegates to discover the port facilities of Marseille, the hub for the Mediterranean and African traffic. Visitors will have the opportunity to discover new buildings of "Euromediterranee" city-port projects and 'Marseille-Provence capital of culture in 2013'. In addition they will see the passenger ferry terminals, RoRo and Ropax terminals, vehicles handling, ship repair, container activity and cruise in front of the famous sea wall Digue du Large. If the weather permits, the tour will continue to the Frioul islands and an overview of the Marseille's bay and the Calanques. The Port of Fos, 70km far from Marseille, is dedicated to deepsea container traffic, logistics and heavy industry.
